## Investment process

### A selective universe: the Coho 250

We narrow our focus to a highly selective universe of companies that have generally shown long-term stability and growth in most economic environments.

### In-depth fundamental research determines attractiveness

We execute thorough research on the Coho 250 universe and construct Dividend Discount Models (DDMs)\* for each company using realistic yet conservative assumptions.

### Portfolio construction

Our buy and sell decisions are driven by the portfolio's risk/return profile.

\*A Dividend Discount Model (DDM) is a procedure for valuing the price of a stock by using the predicted dividends and discounting them back to the present value.

\*Coho Partners, Ltd. Fees waived and expenses paid by the Adviser may be recouped by the Adviser for a period of 36 months following the month during which such fee waiver and expense payment was made if such recoupment can be achieved without exceeding the expense limit in effect at the time the fee waiver and expense payment occurred and the expense limit in place at the time of recoupment. The Operating Expenses Limitation Agreement is indefinite in term, but cannot be terminated through at least November 28, 2022. Thereafter, the agreement may be terminated at any time upon 60 days' written notice by the Trust's Board of Trustees or the Adviser, with the consent of the Board.

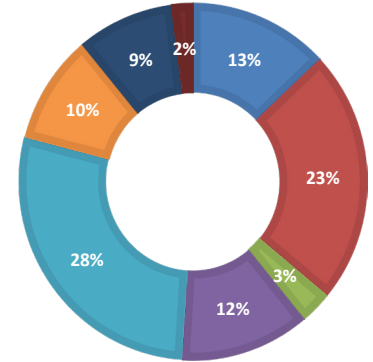
